#### Mr. Chairman and Members of the Committee:

I want to thank you for the opportunity to appear before you in support of SB 264. I am Allie Devine, representing the Kansas Alliance of Boys & Girls Clubs (Clubs) and speaking to you today on behalf of our Clubs across Kansas.

#### **Background:**

Boys & Girls Clubs fill the gap between school and home, providing safe environments where kids participate in life-changing programs, form supportive relationships with peers and caring adults, and basic needs are met. More than 34,000 youth are served through membership and community outreach in over 40 Club sites in Kansas communities each year. In 2019, nearly 300,000 meals and over 700,000 snacks were provided to Club kids in Kansas. Clubs offer nationally recognized programs that include articulated and measured goals and are affiliated with Boys & Girls Clubs of America, adhering to their internal standards, as well as with state drop-in licensing requirements.

Alliance Clubs are based in Hutchinson, Atchison, Manhattan, Wichita, Topeka, Lawrence, Coffeyville, Kansas City (KS), Ft. Leavenworth, Kickapoo Tribe in Horton, Potawatomi Nation in Mayetta, and the Iowa Tribe in White Cloud. Of Clubs' overall operating income totaling \$10.6 million, 40% is derived from local, state, and federal funding, with remaining revenue coming from private sources including individuals, businesses, and foundations.

Attached you will find the Kansas Alliance of Boys & Girls Fact Sheet. I would like to draw your attention to the membership demographics and data regarding out of school time and health and wellness. The Clubs have targeted prevention programs that serve some of the most vulnerable and needy Kansans. Over the last year, Clubs have been instrumental in providing much needed services to youth, including on-line learning and access to technology, checking in on the welfare of their Club kids, offering kids activity packets or virtual activities while isolated at home, and providing meals to kids, their families, and communities. Many of you are familiar with the Clubs' partnership with Kansas Department of Children and Families and use of Temporary Assistance to Needy Families, and the supplemental funding that was available through the CARES Act and Kansas Recovery office to help in these programs.

# Support of SB 264 and youth drug prevention programs:

We are here today to ask your support for SB 264 and encourage use of opioid funds for youth prevention programs. We all understand that youth prevention programs are effective. Recently, Dr.

Jeff Jenson, Ph.D, Philip D. & Eleanor G. Winn Endowed Professor for Children and Youth, Graduate School of Social Work - University of Denver, commented to the Colorado legislature regarding youth drug prevention programs. He noted;

# The key to reducing the opioid epidemic, is drug abuse prevention.

- > Substance misuse causes harm in childhood and adolescence.
- Substance misuse established in adolescence causes harm into adulthood.
- Preventing substance misuse during childhood and adolescence can reduce mortality and morbidity over the life course.
- > Treatment and life-saving naloxone will not prevent new uptake of opioids, allowing the cycle of drug abuse and wasted lives to continue.

We commend the work of Attorney General Schmidt and his staff in pursuing the abuse of opioids and the crafting of SB 264. We have confirmed with the General's office that the Kansas Alliance of Boys & Girls Clubs or individual Clubs would be eligible applicants for funding. We look forward to applying and working with the Attorney General's office and Sunflower foundation to assist Kansas youth in combating drug abuse. Thank you for your time.

15% of young people in Kansas fail to graduate from high school on time.
