1 AN ACT making and concerning appropriations for the fiscal years June
2 30, 2022, June 30, 2023, June 30, 2024, and June 30, 2025, for state
3 agencies; authorizing certain transfers, capital improvement projects
4 and fees, imposing certain restrictions and limitations, and directing or
5 authorizing certain receipts, disbursements, procedures and acts
6 incidental to the foregoing; amending K.S.A. 2021 Supp. 74-50,107
7 and repealing the existing section.
8

9 *Be it enacted by the Legislature of the State of Kansas:*

10 Section 1. (a) For the fiscal years ending June 30, 2022, June 30,
11 2023, June 30, 2024, and June 30, 2025, appropriations are hereby made,
12 restrictions and limitations are hereby imposed, and transfers, capital
13 improvement projects, fees, receipts, disbursements, procedures and acts
14 incidental to the foregoing are hereby directed or authorized as provided in
15 this act.

16 (b) The agencies named in this act are hereby authorized to initiate
17 and complete the capital improvement projects specified and authorized by
18 this act or for which appropriations are made by this act, subject to the
19 restrictions and limitations imposed by this act.

20 (c) This act shall not be subject to the provisions of K.S.A. 75-
21 6702(a), and amendments thereto.

22 (d) The appropriations made in this act shall not be subject to the
23 provisions of K.S.A. 46-155, and amendments thereto.
