1 AN ACT concerning crimes, punishment and criminal procedure; creating
2 the crimes of trespassing on a critical infrastructure facility and
3 criminal damage to a critical infrastructure facility; eliminating the
4 crime of tampering with a pipeline; **requiring payment of restitution**;
5 amending K.S.A. 2020 Supp. 21-5818 ~~and~~, 21-6328 **and 21-6604** and
6 repealing the existing sections.

8 *Be it enacted by the Legislature of the State of Kansas:*

9 Section 1. K.S.A. 2020 Supp. 21-5818 is hereby amended to read as
10 follows: 21-5818. (a) ~~Tampering with a pipeline is the knowing and~~
11 ~~unauthorized alteration of or interference with any part of a pipeline.~~
12 *Trespassing on a critical infrastructure facility is, without consent of the*
13 *owner or the owner's agent, knowingly entering or remaining in:*

14 (1) *A critical infrastructure facility; or*

15 (2) *any property containing a critical infrastructure facility, if such*
16 *property is completely enclosed by a fence or other physical barrier that is*
17 *obviously designed to exclude intruders or is clearly marked with a sign or*
18 *signs that are posted on the property that are reasonably likely to come to*
19 *the attention of intruders and indicate that entry is forbidden without site*
20 *authorization.*

21 (b) ~~Tampering with a pipeline is a severity level 6, nonperson felony.~~
22 *Aggravated trespassing on a critical infrastructure facility is:*

23 (1) *Knowingly entering or remaining in:*

24 (A) *A critical infrastructure facility; or*

25 (B) *any property containing a critical infrastructure facility, if such*
26 *property is completely enclosed by a fence or other physical barrier that is*
27 *obviously designed to exclude intruders or is clearly marked with a sign or*
28 *signs that are posted on the property that are reasonably likely to come to*
29 *the attention of intruders and indicate that entry is forbidden without site*
30 *authorization; and*

31 (2) *with the intent to damage, destroy, ~~vandalize, deface~~ or tamper*
32 *with a critical infrastructure facility or impede or inhibit operations of the*
33 *facility.*

34 (c) *Criminal damage to a critical infrastructure facility is knowingly*

1 ~~damaging, destroying, vandalizing, defacing~~ or tampering with a critical
2 ~~infrastructure facility.~~

3 (d) ~~Aggravated criminal damage to a critical infrastructure facility is~~
4 ~~knowingly damaging, destroying, vandalizing, defacing~~ or tampering with
5 ~~a critical infrastructure facility with the intent to impede or inhibit~~
6 ~~operations of the facility.~~

7 (e) (1) ~~Trespassing on a critical infrastructure facility is a class A~~
8 ~~nonperson misdemeanor.~~

9 (2) ~~Aggravated trespassing on a critical infrastructure facility is a~~
10 ~~severity level 7, nonperson felony.~~

11 (3) ~~Criminal damage to a critical infrastructure facility is a severity~~
12 ~~level 6, nonperson felony.~~

13 (4) ~~Aggravated criminal damage to a critical infrastructure facility is~~
14 ~~a severity level 5, nonperson felony.~~

15 ~~(f)-(1) Any person who is arrested for a violation of this section or~~
16 ~~convicted under this section may be held liable for any damages to~~
17 ~~personal or real property. Any person or entity that provides consideration~~
18 ~~or remuneration to a person to commit an act as described in this section~~
19 ~~may also be held liable for any damages to personal or real property~~
20 ~~caused by such person.~~

21 ~~(2) In determining the amount of damage to property, damages may~~
22 ~~include:~~

23 ~~(A) The cost of repair or replacement of the property that was~~
24 ~~damaged;~~

25 ~~(B) the reasonable cost of the loss of production, crops and livestock;~~

26 ~~(C) reasonable labor costs of any kind;~~

27 ~~(D) reasonable material costs of any kind; and~~

28 ~~(E) any reasonable costs that are attributed to equipment that is used~~
29 ~~to abate or repair the damage to the property.~~

30 ~~(g) Nothing in this section shall be construed to prevent:~~

31 ~~(1) An owner or operator of a critical infrastructure facility that~~
32 ~~has been damaged from pursuing any other remedy in law or equity; or~~

33 ~~(2) a person who violates the provisions of this section may also be~~
34 ~~from being prosecuted for, convicted of and punished for any other offense~~
35 ~~in article 58 of chapter 21 of the Kansas Statutes Annotated, and~~
36 ~~amendments thereto, or K.S.A. 66-2303, and amendments thereto.~~

37 ~~(e)(h)(g) As used in this section:~~

38 ~~(1) "Alteration of or interference with any part of a pipeline"~~
39 ~~includes, but is not limited to, any adjustment, opening, removal, change~~
40 ~~or destruction of any part of any pipeline; and~~

41 ~~(2) "pipeline" means any pipeline, and any related facility, building,~~
42 ~~structure or equipment, used in gathering, transmission or transportation of~~
43 ~~natural gas, crude oil, petroleum products or anhydrous ammonia.~~

1 "Pipeline" does not include distribution lines that convey natural gas from
2 a gas main to the ultimate consumer, "critical infrastructure facility"
3 means ~~any~~:

4 (1) Petroleum or alumina refinery;

5 (2) ~~facility generating electrical power~~ **electric generation facility,**
6 *substation, switching station, electrical control center, electric-power-*
7 *lines, including lines used for the transmission of electricity* **distribution**
8 **or transmission lines,** or associated equipment infrastructure;

9 (3) chemical, polymer or rubber manufacturing facility;

10 (4) ~~water intake structure, water treatment facility;~~ **water supply**
11 **diversion, production, treatment, storage or distribution facility and**
12 **appurtenances, including, but not limited to, underground pipelines and**
13 **a wastewater treatment plant or pump station;**

14 (5) natural gas compressor station;

15 (6) liquid natural gas or propane terminal or storage facility;

16 (7) facility that is used for wireline, broadband or wireless
17 telecommunications **or video services** infrastructure, including backup
18 power supplies **and cable television headend;**

19 (8) port, railroad switching yard, railroad tracks, trucking terminal
20 or other freight transportation facility;

21 (9) gas processing plant, including a plant used in the processing,
22 treatment or fractionation of natural gas, propane or natural gas liquids;

23 (10) transmission facility used by a federally licensed radio or
24 television station;

25 (11) steelmaking facility that uses an electric arc furnace to make
26 steel;

27 (12) facility identified and regulated by the United States department
28 of homeland security chemical facility anti-terrorism standards program, **a**
29 **facility operated by the office of laboratory services under the**
30 **supervision of the secretary of health and environment pursuant to**
31 **K.S.A. 75-5608, and amendments thereto, the national bio and agro-**
32 **defense facility or the biosecurity research institute at Kansas state**
33 **university;**

34 (13) dam that is regulated by the state **as a hazard class B or C dam**
35 **or by the federal government;**

36 (14) natural gas distribution utility facility **or natural gas**
37 **transmission facility,** including, but not limited to, pipeline
38 interconnections, a city gate or town border station, metering station,
39 belowground or aboveground piping, a regular station or a natural gas
40 storage facility;

41 (15) crude oil, including y-grade or natural gas liquids, or refined
42 products storage and distribution facility, including, but not limited to,
43 valve sites, pipeline interconnections, pump station, metering station,

1 *belowground or aboveground pipeline or piping and truck loading or*
2 *offloading facility; or*

3 *(16) portion of any belowground or aboveground oil, gas, hazardous*
4 *liquid or chemical pipeline, tank, railroad facility or any other storage*
5 *facility that is enclosed by a fence or other physical barrier or is clearly*
6 *marked with signs prohibiting trespassing, that are obviously designed to*
7 *exclude intruders.*

8 Sec. 2. K.S.A. 2020 Supp. 21-6328 is hereby amended to read as
9 follows: 21-6328. As used in the Kansas racketeer influenced and corrupt
10 organization act:

11 (a) (1) "Beneficial interest" means:

12 ~~(A)~~(A) The interest of a person as a beneficiary under any trust
13 arrangement pursuant to which a trustee holds legal or record title to real
14 property for the benefit of such person; or

15 ~~(B)~~(B) the interest of a person under any other form of express

18 (2) The term "beneficial interest" does not include the interest of a
19 stock holder in a corporation or the interest of a partner in either a general
20 partnership or a limited partnership. A beneficial interest shall be deemed
21 to be located where the real property owned by the trustee is located.

22 (b) "Covered person" means any person who:

23 (1) Is a criminal street gang member or criminal street gang associate,
24 as defined in K.S.A. 2020 Supp. 21-6313, and amendments thereto;

25 (2) has engaged in or is engaging in any conduct prohibited by K.S.A.
26 2020 Supp. 21-5426, and amendments thereto, human trafficking or
27 aggravated human trafficking, or K.S.A. 2020 Supp. 21-6422, and
28 amendments thereto, commercial sexual exploitation of a child; or

29 (3) has engaged in or is engaging in any conduct prohibited by K.S.A.
30 2020 Supp. 21-5703, and amendments thereto, unlawful manufacturing of
31 controlled substances, or K.S.A. 2020 Supp. 21-5705, and amendments
32 thereto, unlawful cultivation or distribution of controlled substances.

33 (c) "Documentary material" means any book, paper, document,
34 writing, drawing, graph, chart, photograph, phonorecord, magnetic tape,
35 computer printout, other data compilation from which information can be
36 obtained or from which information can be translated into usable form, or
37 other tangible item.

38 (d) "Enterprise" means any individual, sole proprietorship,
39 partnership, corporation, business trust, union chartered under the laws of
40 this state, or other legal entity, or any unchartered union, association, or
41 group of individuals associated in fact although not a legal entity; and it
42 includes illicit as well as licit enterprises and governmental, as well as
43 other, entities. A criminal street gang, as defined in K.S.A. 2020 Supp. 21-

1 6313, and amendments thereto, constitutes an enterprise.

2 (e) "Pattern of racketeering activity" means engaging in at least two
3 incidents of racketeering activity that have the same or similar intents,
4 results, accomplices, victims or methods of commission or that otherwise
5 are interrelated by distinguishing characteristics and are not isolated
6 incidents, provided at least one of such incidents occurred after the
7 effective date of this act and that the last of such incidents occurred within
8 *5 five* years, excluding any period of imprisonment, after a prior incident
9 of racketeering activity.

10 (f) "Racketeering activity" means to commit, attempt to commit,
11 conspire to commit or to solicit, coerce or intimidate another person to
12 commit:

39 (A) Any person acting as trustee pursuant to a trust in which the
40 trustee holds legal or record title to real property;

41 (B) any person who holds legal or record title to real property in
42 which any other person has a beneficial interest; or

43 (C) any successor trustee or trustees to any or all of the foregoing

1 persons.

2 (2) The term "trustee" does not include any person appointed or
3 acting as a personal representative as defined in K.S.A. 59-102, and
4 amendments thereto, or appointed or acting as a trustee of any
5 testamentary trust or as a trustee of any indenture of trust under which any
6 bonds have been or are to be issued.

7 (i) "Unlawful debt" means any money or other thing of value
8 constituting principal or interest of a debt that is legally unenforceable in
9 this state in whole or in part because the debt was incurred or contracted:

10 (1) In violation of any of the following provisions of law: Article 88
11 of chapter 74 of the Kansas Statutes Annotated, and amendments thereto,
12 Kansas parimutuel racing act; K.S.A. 2020 Supp. 21-6404, and
13 amendments thereto, gambling; K.S.A. 2020 Supp. 21-6405, and
14 amendments thereto, illegal bingo operation; K.S.A. 2020 Supp. 21-6406,
15 and amendments thereto, commercial gambling; K.S.A. 2020 Supp. 21-
16 6407, and amendments thereto, dealing in gambling devices; K.S.A. 2020
17 Supp. 21-6408, and amendments thereto, unlawful possession of a
18 gambling device; or K.S.A. 2020 Supp. 21-6409, and amendments thereto,
19 installing communication facilities for gamblers; or

20 (2) in gambling activity in violation of federal law or in the business
21 of lending money at a rate usurious under state or federal law.

22 ***Sec. 3. K.S.A. 2020 Supp. 21-6604 is hereby amended to read as***
23 ***follows: 21-6604. (a) Whenever any person has been found guilty of a***
24 ***crime, the court may adjudge any of the following:***

25 ***(1) Commit the defendant to the custody of the secretary of***
26 ***corrections if the current crime of conviction is a felony and the***
27 ***sentence presumes imprisonment, or the sentence imposed is a***
28 ***dispositional departure to imprisonment; or, if confinement is for a***
29 ***misdemeanor, to jail for the term provided by law;***

30 ***(2) impose the fine applicable to the offense and may impose the***
31 ***provisions of subsection (q);***

32 ***(3) release the defendant on probation if the current crime of***
33 ***conviction and criminal history fall within a presumptive nonprison***
34 ***category or through a departure for substantial and compelling reasons***
35 ***subject to such conditions as the court may deem appropriate. In felony***
36 ***cases except for violations of K.S.A. 8-1567 or 8-2,144, and amendments***
37 ***thereto, the court may include confinement in a county jail not to exceed***
38 ***60 days, which need not be served consecutively, as a condition of an***
39 ***original probation sentence;***

40 ***(4) assign the defendant to a community correctional services***
41 ***program as provided in K.S.A. 75-5291, and amendments thereto, or***

1 *requiring full or partial restitution;*

2 (5) *assign the defendant to a conservation camp for a period not to*
3 *exceed six months as a condition of probation followed by a six-month*
4 *period of follow-up through adult intensive supervision by a community*
5 *correctional services program, if the offender successfully completes the*
6 *conservation camp program;*

7 (6) *assign the defendant to a house arrest program pursuant to*
8 *K.S.A. 2020 Supp. 21-6609, and amendments thereto;*

9 (7) *order the defendant to attend and satisfactorily complete an*
10 *alcohol or drug education or training program as provided by K.S.A.*
11 *2020 Supp. 21-6602(c), and amendments thereto;*

12 (8) *order the defendant to repay the amount of any reward paid by*
13 *any crime stoppers chapter, individual, corporation or public entity that*
14 *materially aided in the apprehension or conviction of the defendant;*
15 *repay the amount of any costs and expenses incurred by any law*
16 *enforcement agency in the apprehension of the defendant, if one of the*
17 *current crimes of conviction of the defendant includes escape from*
18 *custody or aggravated escape from custody, as defined in K.S.A. 2020*
19 *Supp. 21-5911, and amendments thereto; repay expenses incurred by a*
20 *fire district, fire department or fire company responding to a fire that*
21 *has been determined to be arson or aggravated arson as defined in*
22 *K.S.A. 2020 Supp. 21-5812, and amendments thereto, if the defendant is*
23 *convicted of such crime; repay the amount of any public funds utilized*
24 *by a law enforcement agency to purchase controlled substances from the*
25 *defendant during the investigation that leads to the defendant's*
26 *conviction; or repay the amount of any medical costs and expenses*
27 *incurred by any law enforcement agency or county. Such repayment of*
28 *the amount of any such costs and expenses incurred by a county, law*
29 *enforcement agency, fire district, fire department or fire company or any*
30 *public funds utilized by a law enforcement agency shall be deposited and*
31 *credited to the same fund from which the public funds were credited to*
32 *prior to use by the county, law enforcement agency, fire district, fire*
33 *department or fire company;*

34 (9) *order the defendant to pay the administrative fee authorized by*

37 *fee authorized by K.S.A. 20-369, and amendments thereto;*

38 (11) *if the defendant is convicted of a misdemeanor or convicted of*
39 *a felony specified in K.S.A. 2020 Supp. 21-6804(i), and amendments*
40 *thereto, assign the defendant to work release program, other than a*
41 *program at a correctional institution under the control of the secretary*
42 *of corrections as defined in K.S.A. 75-5202, and amendments thereto,*
43 *provided such work release program requires such defendant to return*

1 *to confinement at the end of each day in the work release program. On a*
2 *second or subsequent conviction of K.S.A. 8-1567, and amendments*
3 *thereto, an offender placed into a work release program shall serve the*
4 *total number of hours of confinement mandated by that section;*

5 *(12) order the defendant to pay the full amount of unpaid costs*
6 *associated with the conditions of release of the appearance bond under*
7 *K.S.A. 22-2802, and amendments thereto;*

8 *(13) impose any appropriate combination of (1), (2), (3), (4), (5),*
9 *(6), (7), (8), (9), (10), (11) and (12); or*

10 *(14) suspend imposition of sentence in misdemeanor cases.*

11 *(b) (1) In addition to or in lieu of any of the above, the court shall*
12 *order the defendant to pay restitution, which shall include, but not be*
13 *limited to, damage or loss caused by the defendant's crime. Restitution*
14 *shall be due immediately unless: (A) The court orders that the defendant*
15 *be given a specified time to pay or be allowed to pay in specified*
16 *installments; or (B) the court finds compelling circumstances that would*
17 *render restitution unworkable, either in whole or in part. In regard to a*
18 *violation of K.S.A. 2020 Supp. 21-6107, and amendments thereto, such*

4 whose offense is classified in grid blocks 4-E or 4-F of the sentencing

43 *If the inmate successfully completes a conservation camp program,*

1 *the secretary of corrections shall report such completion to the*
2 *sentencing court and the county or district attorney. The inmate shall*
3 *then be assigned by the court to six months of follow-up supervision*
4 *conducted by the appropriate community corrections services program.*
5 *The court may also order that supervision continue thereafter for the*
6 *length of time authorized by K.S.A. 2020 Supp. 21-6608, and*
7 *amendments thereto.*

8 *(m) When it is provided by law that a person shall be sentenced*
9 *pursuant to K.S.A. 1993 Supp. 21-4628, prior to its repeal, the provisions*
10 *of this section shall not apply.*

11 *(n) (1) Except as provided by K.S.A. 2020 Supp. 21-6630 and 21-*
12 *6805(f), and amendments thereto, in addition to any of the above, for*
13 *felony violations of K.S.A. 2020 Supp. 21-5706, and amendments*
14 *thereto, the court shall require the defendant who meets the*
15 *requirements established in K.S.A. 2020 Supp. 21-6824, and*
16 *amendments thereto, to participate in a certified drug abuse treatment*
17 *program, as provided in K.S.A. 75-52,144, and amendments thereto,*
18 *including, but not limited to, an approved after-care plan. The amount*
19 *of time spent participating in such program shall not be credited as*
20 *service on the underlying prison sentence.*

21 *(2) If the defendant fails to participate in or has a pattern of*
22 *intentional conduct that demonstrates the defendant's refusal to comply*
23 *with or participate in the treatment program, as established by judicial*
24 *finding, the defendant shall be subject to sanction or revocation*
25 *pursuant to the provisions of K.S.A. 22-3716, and amendments thereto.*
