1 AN ACT concerning insurance; relating to the captive insurance act;  
2 authorizing technology-enabled fiduciary financial institution insurance  
3 companies; providing for the certificate of authority, requirements and  
4 operations thereof; amending K.S.A. 40-4301, 40-4302, 40-4303, 40-  
5 4310 and 40-4353 and repealing the existing sections.  
6

7 *Be it enacted by the Legislature of the State of Kansas:*

8 New Section 1. (a) In addition to the types of insurance permitted  
9 under K.S.A. 40-4302, and amendments thereto, the certificate of authority  
10 issued to a technology-enabled fiduciary financial institution insurance  
11 company shall authorize such insurance company to provide contracts of  
12 suretyship or credit insurance where the obligee under the contract of  
13 suretyship or the insured under the contract of credit insurance, as the case  
14 may be, is:

- 15 (1) An affiliated technology-enabled fiduciary financial institution;  
16 (2) an affiliated fidfin trust; or  
17 (3) any other affiliated company.

18 (b) (1) In addition to the types of insurance otherwise permitted, and  
19 without any limitation, under K.S.A. 40-4302, and amendments thereto,  
20 the certificate of authority issued to a technology-enabled fiduciary  
21 financial institution insurance company shall authorize such insurance  
22 company to insure its affiliated companies that are investors in an  
23 investment fund against liability, loss or damage resulting from owning an  
24 interest in an investment fund from any of the following risks:

25 (A) Fraud, theft or conversion of assets by a manager of an  
26 investment fund;

27 (B) the obligation of an investor in an investment fund to indemnify  
28 or exculpate a manager of such investment fund;

29 (C) any obligation of an affiliated technology-enabled fiduciary  
30 financial institution, affiliated fidfin trust or affiliated company to  
31 indemnify or exculpate an affiliated company or an investment fund in  
32 which any affiliated fidfin trust is an investor, or of which an affiliated  
33 fidfin trust is an affiliated company or of which any affiliated fidfin trust is  
34 a manager;

1 (D) the inability of an investor to recover damages from a manager of  
2 such investment fund as a result of exculpation provisions in the governing  
3 documents of such investment fund;

4 (E) breach of representations or warranties made by a transferor,  
5 assignor or investor in an investment fund in connection with a transfer or  
6 assignment of an interest in an investment fund; or

7 (F) breach of an obligation of a transferor, assignor or investor in an  
8 investment fund to pass through to the transferee, assignee or substitute  
9 investor in an investment fund any and all economic benefits of a  
10 transferred or assigned interest in an investment fund.

11 (2) To the extent that such coverages in this subsection are not  
12 included within any of the classes enumerated in K.S.A. 40-1102, and  
13 amendments thereto, such coverages shall be deemed as included in  
14 K.S.A. 40-1102(1)(n), and amendments thereto, and the commissioner  
15 shall assign such coverages to an appropriate line of business for financial  
16 reporting purposes and all other purposes under chapter 40 of the Kansas  
17 Statutes Annotated, and amendments thereto.

18 (c) For the purpose of any policy or product offered by a technology-  
19 enabled fiduciary financial *institution insurance* company as insurance,  
20 fortuitous events shall include, without limitation:

21 (1) The denial of, or failure to provide, consent by a manager of an  
22 investment fund to the assignment or transfer of interests in an investment  
23 fund from an investor to an affiliated fidfin trust;

24 (2) any action taken by a manager of an investment fund that affects  
25 the economic value of an investor's interest in an investment fund in  
26 response to the attempted transfer of such interest in an investment fund to  
27 an affiliated fidfin trust;

28 (3) after an attempted transfer of an interest in an investment fund  
29 from an investor to an affiliated fidfin trust, the failure of such investor to  
30 transmit any distributions or other economic value from such interest in an  
31 investment fund to the applicable affiliated fidfin trust;

32 (4) after an attempted transfer of an interest in an investment fund  
33 from an investor to an affiliated fidfin trust, any action taken by another  
34 investor in such investment fund that affects:

35 (A) The economic value of such interest in an investment fund; or

36 (B) such transferor's ability to transfer such interest in an investment  
37 fund to the applicable affiliated fidfin trust; and

38 (5) any other risks related to the transfer of an interest in an  
39 investment fund from an investor to an affiliated fidfin trust.

40 (d) Notwithstanding the provisions of K.S.A. 40-4303, and  
41 amendments thereto, a technology-enabled fiduciary financial institution  
42 insurance company shall not be required to incorporate the word "captive"  
43 into its name if such insurance company incorporates into its name any of

1 the following identifiers:

2 (1) "Technology-enabled fiduciary financial institution insurance  
3 company" or "TEFFI insurance company";

4 (2) "Kansas e-commerce fidfin insurance company"; or

5 (3) "KEFFI."

6 (e) For purposes of K.S.A. 40-4302(b)(3), and amendments thereto,  
7 the principal place of business in this state of a technology-enabled  
8 fiduciary financial institution insurance company may be located in the  
9 same or shared office premises with an affiliated technology-enabled  
10 fiduciary financial institution or other technology-enabled fiduciary  
11 financial institution insurance company.

12 (f) Any natural person who serves as a member of the board of  
13 directors of an affiliated technology-enabled fiduciary financial institution  
14 or other affiliated company may concurrently fulfill the Kansas residency  
15 requirement of K.S.A. 9-2306(b), and amendments thereto, and may:

16 (1) Serve on the board of directors of a technology-enabled fiduciary  
17 financial institution insurance company that is organized as a corporation  
18 or serve as a manager of a technology-enabled fiduciary financial  
19 institution that is organized as a limited liability company; and

20 (2) fulfill the applicable Kansas residency requirements of K.S.A. 40-  
21 4306(d), and amendments thereto.

22 (g) (1) A technology-enabled fiduciary financial institution insurance  
23 company may enter into service contracts with any other technology-  
24 enabled fiduciary financial institution insurance company, an affiliated  
25 technology-enabled fiduciary financial institution or affiliated companies  
26 that provide for services to be performed:

27 (A) For the technology-enabled fiduciary financial institution  
28 insurance company, including such insurance companies that operate with  
29 or without direct employees; or

30 (B) by the technology-enabled fiduciary financial institution  
31 insurance company.

32 (2) Any personnel who perform services for a technology-enabled  
33 fiduciary financial institution insurance company, either as employees of  
34 such insurance company or pursuant to service contracts, may  
35 concurrently perform services for any other technology-enabled fiduciary  
36 financial institution insurance company, an affiliated technology-enabled  
37 fiduciary financial institution or an affiliated company thereof, either as  
38 employees or pursuant to service contracts.

39 (h) (1) If a technology-enabled fiduciary financial institution  
40 insurance company issues payment-in-kind policies that expressly require  
41 such insurance company to hold a sufficient amount of in-kind assets to  
42 meet the full obligations of such payment-in-kind policies, such insurance  
43 company shall hold in-kind assets in a total amount determined to be

1 actuarially prudent to meet its obligations to make claim payments under  
2 such payment-in-kind policies, but in no event shall such amount be less  
3 than the sum of the aggregate obligations of and for all such payment-in-  
4 kind policies. If a technology-enabled fiduciary financial institution  
5 insurance company issues payment-in-kind policies that do not expressly  
6 require such insurance company to hold a certain amount of in-kind assets,  
7 such insurance company shall hold in-kind assets to the extent determined  
8 to be actuarially prudent by such insurance company and confirmed by a  
9 third-party actuary selected by such insurance company, to enable such  
10 insurance company to meet its obligations to make claim payments under  
11 such payment-in-kind policies. Such third-party actuary shall have an  
12 actuarial designation meeting the national association of insurance  
13 commissioners minimum property and casualty actuarial educational  
14 standards for a property and casualty appointed actuary as published on the  
15 website for the national association of insurance commissioners. For the  
16 purposes of the captive insurance act, a technology-enabled fiduciary  
17 financial institution insurance company shall value any in-kind asset or  
18 combination of in-kind assets in accordance with generally accepted  
19 accounting principles, as applied by such insurance company in its sole  
20 discretion.

21 (2) A technology-enabled fiduciary financial institution insurance  
22 company shall satisfy claims under a payment-in-kind policy by delivering  
23 to the qualified policyholder in-kind assets or a combination of in-kind  
24 assets pursuant to the schedules attached to such payment-in-kind policy.  
25 The in-kind assets or combination of in-kind assets delivered to a qualified  
26 policyholder may be:

27 (A) An interest or interests in an investment fund that is the subject of  
28 such payment-in-kind policy; or

29 (B) any other in-kind assets or combination of in-kind assets as shall  
30 be selected by such insurance company in its sole discretion if such assets  
31 have a like or equal value and otherwise comply with the schedules  
32 attached to such payment-in-kind policy.

33 (3) Any in-kind assets held pursuant to this subsection shall be  
34 required to be counted as part of the reserves, capital and surplus of a  
35 technology-enabled fiduciary financial institution insurance company  
36 maintained and reported as for the primary and predominant business  
37 activity of the writing of insurance or the reinsuring of risks, except that a  
38 technology-enabled fiduciary financial institution insurance company that  
39 satisfies the requirements of K.S.A. 40-4304, and amendments thereto,  
40 shall not be required to hold any other assets so long as such in-kind assets  
41 are sufficient to meet its obligations to make claim payments under  
42 payment-in-kind policies by delivering such in-kind assets to qualified  
43 policyholders.

1 (4) All revenue and income generated by the in-kind assets required  
2 to be held pursuant to this subsection, including interest, capital gains and  
3 investment revenue and income, whether realized or unrealized, shall be  
4 deemed income derived from the business activity of the writing of  
5 insurance or the reinsuring of risks underwritten by technology-enabled  
6 fiduciary financial institution insurance companies. If such amounts  
7 represent net income, then such income shall be reported as statutory  
8 revenues from the business activity of the writing of insurance or the  
9 reinsuring of risks. If such amounts represent a net loss, then such loss  
10 shall be reported as statutory net losses included with losses from claims.  
11 Such amounts shall be reported and included in ~~a statutory profit and loss~~  
12 ~~financial statement~~ **statements**. All payment-in-kind assets required to be  
13 held by a technology-enabled fiduciary financial institution insurance  
14 company under this subsection shall be reported on its statutory balance  
15 sheet as being dedicated to the satisfaction of such company's payment-in-  
16 kind obligations resulting from the business activity of the writing of  
17 insurance or the reinsuring of risks.

18 (5) A technology-enabled fiduciary financial institution insurance  
19 company will be required to report any items required to be included under  
20 this subsection in a statutory financial statement in the segment reporting  
21 section of the footnotes prepared in accordance with generally accepted  
22 accounting principles.

23 (6) A technology-enabled fiduciary financial institution insurance  
24 company will be required to include in its complete statutory financial  
25 statements in the footnotes reporting other information prepared in  
26 accordance with generally accepted accounting principles.

27 (i) Any insurance company regardless of the jurisdiction in which  
28 such insurance company is organized and operates is permitted to hold  
29 equity interests in an affiliated technology-enabled fiduciary financial  
30 institution and may utilize such equity interests as in-kind assets when  
31 issuing payment-in-kind policies to such affiliated technology-enabled  
32 fiduciary financial institution or other qualified policyholder.

33 (j) A technology-enabled fiduciary financial institution insurance  
34 company shall not be required to employ, engage or contract more than  
35 one employee in this state to provide services for such technology-enabled  
36 fiduciary financial institution insurance company or to facilitate any  
37 examinations required by the captive insurance act.

38 (k) A technology-enabled fiduciary financial institution insurance  
39 company or other insurance company organized under the provisions of  
40 K.S.A. 40-4306, and amendments thereto, that has been issued a certificate  
41 of authority under K.S.A. 40-4302, and amendments thereto, shall be an  
42 "insurance company" as defined in K.S.A. 40-222c, and amendments  
43 thereto. An insurance company described in this subsection shall be

1 considered to have as its primary and predominant business activity the  
2 writing of insurance or the reinsuring of risks underwritten by insurance  
3 companies and shall be subject to the supervision of the commissioner.

4 (l) ***A technology-enabled fiduciary financial institution insurance***  
5 ***company that has been issued a certificate of authority under K.S.A. 40-***  
6 ***4302, and amendments thereto, shall be permitted, subject to compliance***  
7 ***with the provisions of K.S.A. 40-214, and amendments thereto, to do***  
8 ***business in any other state or territory of the United States.***

9 (m) A technology-enabled fiduciary financial institution policy may  
10 include a provision that such policy shall be governed by, and construed in  
11 accordance with, the laws of the state of Kansas and such policy provision  
12 shall control over any contrary provision of state law regarding conflict of  
13 laws.

14 ~~(m)~~(n) A technology-enabled fiduciary financial institution policy  
15 may include a provision that any suit, action or proceeding arising out of  
16 or relating to such technology-enabled fiduciary financial institution policy  
17 shall be brought in any district court of this state or the United States  
18 district court for the district of Kansas and any such provision shall be  
19 fully enforceable.

20 (o) ***A technology-enabled fiduciary financial institution policy***  
21 ***issued in connection with an affiliated fidfin trust or fidfin transaction***  
22 ***as defined in K.S.A. 2021 Supp. 9-2301, and amendments thereto, shall***  
23 ***respect the form, treatment and character of such affiliated fidfin trust***  
24 ***or fidfin transaction under the laws of this state notwithstanding the***  
25 ***treatment or characterization of such transaction under generally***  
26 ***accepted accounting principles or for tax purposes.***

27 ~~(n)~~(p) A payment-in-kind policy issued to a qualified policyholder  
28 shall be fully enforceable in accordance with such policy's terms and  
29 conditions as defined in K.S.A. 40-4301, and amendments thereto.

30 ~~(o)~~(q) The provisions of this section shall be construed in a manner  
31 that shall not be disruptive to state efforts to establish a coherent policy  
32 with respect to a technology-enabled fiduciary financial institution  
33 insurance company, a technology-enabled fiduciary financial institution  
34 policy, payment-in-kind policies, technology-enabled fiduciary financial  
35 institutions or any other matter of substantial public concern related  
36 thereto.

37 ~~(p)~~(r) This section shall be a part of and supplemental to the captive  
38 insurance act.

39 Sec. 2. K.S.A. 40-4301 is hereby amended to read as follows: 40-  
40 4301. As used in the captive insurance act, unless the context requires  
41 otherwise:

42 (a) "Affiliated company" means any person, other than a natural  
43 person in that person's individual capacity, in the same corporate system as

1 a parent, or an associate member by common ownership, control,  
2 operation or management, *any affiliated fidfin trust and any affiliated*  
3 *technology-enabled fiduciary financial institution.*

4 (b) *"Affiliated fidfin trust" means a trust, including a fidfin trust of*  
5 *which an affiliated technology-enabled fiduciary financial institution acts*  
6 *as a trustee or custodian.*

7 (c) *"Affiliated technology-enabled fiduciary financial institution"*  
8 *means a technology-enabled fiduciary financial institution:*

9 (1) *That is related to a technology-enabled fiduciary financial*  
10 *institution insurance company by common ownership; or*

11 (2) *at least 5% of the equity interests of which, including any equity*  
12 *interests in the technology-enabled fiduciary financial institution's holding*  
13 *company are owned directly, indirectly or beneficially by a technology-*  
14 *enabled fiduciary financial institution insurance company. In calculating a*  
15 *technology-enabled fiduciary financial institution insurance company's*  
16 *ownership of a technology-enabled fiduciary financial institution:* (A)  
17 *Both voting and nonvoting equity interests shall be included in such*  
18 *calculation; and (B) any equity interests of the technology-enabled*  
19 *fiduciary financial institution owned by an affiliate of such technology-*  
20 *enabled fiduciary financial institution insurance company shall be*  
21 *attributed to such technology-enabled fiduciary financial institution*  
22 *insurance company.*

23 ~~(b)~~(d) *"Association" means any legal association of persons,*  
24 *corporations, limited liability companies, partnerships, associations or*  
25 *other entities that have been in continuous existence for at least one year or*  
26 *such lesser period of time approved by the commissioner, whether or not*  
27 *in conjunction with some or all of the member organizations that:*

28 (1) *Own, control or hold with power to vote all of the outstanding*  
29 *voting securities of an association captive insurance company incorporated*  
30 *as a stock insurer;*

31 (2) *have complete voting control over an association captive*  
32 *insurance company incorporated as a mutual insurer;*

33 (3) *constitute all of the subscribers of an association captive insurance*  
34 *company formed as a limited liability company; or*

35 (4) *have complete voting control over an association captive*  
36 *insurance company formed as a limited liability company.*

37 ~~(e)~~(e) *"Association captive insurance company" means any captive*  
38 *insurance company that insures risks of association members.*

39 ~~(f)~~(f) *"Association member" means any person that belongs to an*  
40 *association.*

41 ~~(g)~~(g) *"Capital and surplus" means the amount by which the value of*  
42 *all of the assets exceeds all of the liabilities of the captive insurance*  
43 *company, as determined under the method of accounting utilized by the*

1 captive insurance company in accordance with the applicable provisions of  
2 this act.

3 ~~(h)~~(h) "Captive insurance company" means any pure captive  
4 insurance company or association captive insurance company. For  
5 purposes of this act, a branch captive insurance company shall be a pure  
6 captive insurance company with respect to operations in this state, unless  
7 otherwise permitted by the commissioner.

8 ~~(i)~~(i) "Commissioner" means the commissioner of insurance.

9 (j) "*Common ownership*" means at least 5% equity ownership,  
10 whether voting or nonvoting, that is held directly, indirectly or beneficially  
11 through one or more entities, including ownership in a technology-enabled  
12 fiduciary financial institution's holding company.

13 ~~(k)~~(k) "Controlled unaffiliated business" means any person other than  
14 a natural person in that natural person's individual capacity:

15 (1) That is not a part of the corporate system of a parent and its  
16 affiliated companies;

17 (2) that has an existing contractual relationship with such parent or  
18 any such affiliated company; and

19 (3) whose risks are managed by a pure captive insurance company.

20 ~~(l)~~(l) "Department" means the Kansas insurance department.

21 ~~(m)~~(m) "Domestic" means any insurance company formed under the  
22 laws of the state of Kansas.

23 (n) "*Fidfin trust*" means the same as defined in K.S.A. 2021 Supp. 9-  
24 2301, and amendments thereto.

25 (o) "*In-kind asset*" means:

26 (1) *Any loan, financing or extension of credit, including to an*  
27 *affiliated fidfin trust, originated by a technology-enabled fiduciary*  
28 *financial institution;*

29 (2) *one or more equity interests in one or more investment funds,*  
30 *each an interest in an investment fund, or one or more equity interests in*  
31 *one or more technology-enabled fiduciary financial institutions;*

32 (3) *any loan, financing or extension of credit secured by the pledge of*  
33 *equity of one or more interests in an investment fund or the cash flow*  
34 *derived therefrom;*

35 (4) *any other assets that serve as collateral securing such loans,*  
36 *equity or debt financing or extensions of credit described in this*  
37 *subsection; and*

38 (5) *any beneficial interests in trusts that own assets described in this*  
39 *subsection that are held by an insurance company for the purpose of*  
40 *enabling such insurance company to meet its obligations to make claim*  
41 *payments under payment-in-kind policies by delivering such assets.*

42 ~~(p)~~(p) "Insurer" means the same as "insurance company" as that term  
43 is defined in K.S.A. 40-222c, and amendments thereto.



1       (q) *"Interest in an investment fund," "equity interest in an investment*  
2 *fund" and terms of similar import mean the ownership or contractual*  
3 *rights to the economics, directly or indirectly, of an investment fund,*  
4 *including pursuant to economic direction agreements, contractual rights,*  
5 *interests and entitlements to any economics derived from an investment*  
6 *fund.*

7       (r) *"Investment fund" means any collective investment vehicle,*  
8 *whether organized as a limited partnership, limited liability company or*  
9 *in some other form, and whether organized in the United States or a*  
10 *foreign jurisdiction, when the interests in such vehicle qualify as*  
11 *alternative assets as defined in K.S.A. 2021 Supp. 9-2301, and*  
12 *amendments thereto.*

13       (s) *"Investor in an investment fund" and terms of similar import*  
14 *means any party who owns an interest in an investment fund.*

15       (t) *"Manager" means with respect to an investment fund, the general*  
16 *partner of a limited partnership, the manager of a limited liability*  
17 *company, any person with equivalent authority in a similar business entity*  
18 *or any investment manager who manages the investments of an investment*  
19 *fund pursuant to a contract.*

20       ~~(u)~~(u) *"Member organization" means any individual, corporation,*  
21 *limited liability company, partnership, association or other entity that*  
22 *belongs to an association.*

23       ~~(v)~~(v) *"Natural person" means a human being.*

24       ~~(w)~~(w) *"Organizational documents" means the captive insurance*  
25 *company's articles of organization, bylaws, operating agreement or other*  
26 *foundational document that establishes the captive insurance company as a*  
27 *legal entity or prescribes its existence.*

28       ~~(x)~~(x) *"Parent" means a corporation, partnership or individual that*  
29 *directly or indirectly owns, controls or holds with power to vote more than*  
30 *50% of the outstanding voting securities or other voting interest of a pure*  
31 *captive insurance company, or as assigned in the plan of operation.*

32       (y) *"Payment-in-kind policy" means a policy that, along with any*  
33 *applicable schedules, is required to be in writing and which satisfies the*  
34 *following conditions:*

35       (1) *The policyholder of such policy is a qualified policyholder;*

36       (2) *is issued by a technology-enabled fiduciary financial institution*  
37 *insurance company or an insurance company organized in a jurisdiction*  
38 *other than Kansas;*

39       (3) *provides that such insurance company has the option, in such*  
40 *insurance company's sole discretion, to make claim payments, in whole or*  
41 *in part, in cash or in the form of in-kind assets rather than cash pursuant*  
42 *to schedules attached to the policy as required by this subsection and*  
43 *agreed to in writing by the qualified policyholder;*

1       (4) provides for such payment-in-kind policy to be fully enforceable  
2 in accordance with such policy's terms and this subsection;

3       (5) may provide for such payment-in-kind policy or provisions  
4 relating to in-kind assets and payments thereof to be governed by, and  
5 construed in accordance with, the laws of the state of Kansas and such  
6 policy or provisions shall control over any contrary provision of state law  
7 regarding conflict of laws and any such provision shall be fully  
8 enforceable;

9       (6) may provide that any suit, action or proceeding arising out of or  
10 relating to such payment-in-kind policy shall be brought in any district  
11 court of this state or the United States district court for the district of  
12 Kansas and any such provision shall be fully enforceable;

13       (7) may be a contract of suretyship or credit insurance in accordance  
14 with section 1, and amendments thereto;

15       (8) contains one or more schedules to such payment-in-kind policy  
16 that sets out a description of the specific in-kind assets that the insurance  
17 company may deliver to the qualified policyholder to make claim  
18 payments as agreed to in writing by the qualified policyholder;

19       (9) may include a copy of the governing documents in effect at the  
20 time of issuance of such payment-in-kind policy of any legal entity that is  
21 the issuer of or obligor under such in-kind assets;

22       (10) includes a provision that the qualified policyholder agrees that  
23 the insurance company has no obligation to provide, and the qualified  
24 policyholder has no additional rights to, any further disclosure regarding  
25 the in-kind assets and shall not rely on any other disclosures provided by  
26 the insurance company other than the disclosure required by this  
27 subsection;

28       (11) includes a provision that the qualified policyholder agrees that  
29 such insurance company has no obligation to make claim payments in any  
30 form other than the in-kind assets specified in such schedules;

31       (12) requires the qualified policyholder to acknowledge that such  
32 insurance company has no obligation to deliver to such qualified  
33 policyholder any underlying assets in the chain of ownership below the in-  
34 kind assets specified in such schedules; and

35       (13) requires the qualified policyholder to acknowledge that:

36       (A) Such qualified policyholder has no recourse against the  
37 insurance company with respect to any in-kind assets other than those in-  
38 kind assets scheduled and attached to such payment-in-kind policy; and

39       (B) any such recourse shall be limited to only those scheduled in-kind  
40 assets that the insurance company, in the insurance company's sole  
41 discretion, makes available to such qualified policyholder as an in-kind  
42 payment in response to a claim initiated by such qualified policyholder.

43       (Ⓟ)(z) "Person" means a natural person, partnership, trust, estate,

1 association, corporation, limited liability company, custodian, nominee or  
2 other individual or entity in its own or any representative capacity, in each  
3 case whether domestic, foreign or alien.

4 (⊕)(aa) "Personal lines of insurance" means personal motor vehicle,  
5 homeowner's insurance coverage, residential fire insurance or any  
6 component thereof.

7 (⊕)(bb) "Pure captive insurance company" means any company that
