1 AN ACT concerning reapportionment; relating to state board of education
2 districts; providing for the reapportionment thereof; repealing K.S.A.
3 2021 Supp. 4-514 and 4-526.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. In accordance with section 3 of article 6 of the constitution
7 of the state of Kansas, the state of Kansas is divided into 10 single-
8 member state board of education districts.

9 Sec. 2. The senatorial districts referred to in sections 4 through 13 are
10 those senatorial districts established by sections 5 through 44 of 2022
11 Substitute for Senate Bill No. 563.

12 Sec. 3. The provisions of this act shall not affect the term of any
13 member of the state board of education elected to represent a district at the
14 general election of 2020 or the term of any successor to such member
15 serving for an unexpired term. All such members shall continue to serve
16 the districts from which elected until such members elected from the
17 districts established by this act commence their terms of office in January
18 of 2025.

19 Sec. 4. State board of education member district one shall consist of
20 senatorial districts 1, 5, 18 and 22.

21 Sec. 5. State board of education member district two shall consist of
22 senatorial districts 4, 6, 7 and 8.

23 Sec. 6. State board of education member district three shall consist of
24 senatorial districts 11, 23, 35 and 37.

25 Sec. 7. State board of education member district four shall consist of
26 senatorial districts 3, 9, 10 and 21.

27 Sec. 8. State board of education member district five shall consist of
28 senatorial districts ~~24~~, 36, **38**, 39 and 40.

29 Sec. 9. State board of education member district six shall consist of
30 senatorial districts 2, 17, 19 and 20.

31 Sec. 10. State board of education member district seven shall consist
32 of senatorial districts **24**, 31, 33; **and** ~~34 and 38~~.

33 Sec. 11. State board of education member district eight shall consist
34 of senatorial districts ~~26, 27~~ **25**, 28, **29** and 30.

35 Sec. 12. State board of education member district nine shall consist of
36 senatorial districts 12, 13, 14 and 15.

1 Sec. 13. State board of education member district ten shall consist of
2 senatorial districts 16,~~25,29~~ **26, 27** and 32.

3 Sec. 14. The attorney general shall certify to the secretary of state that
4 the supreme court has entered a judgment that 2022 Substitute for Senate
5 Bill No. 563 is a valid reapportionment of state senatorial districts. Upon
6 receipt of such notice, the secretary of state shall cause a notice of such
7 certification to be published in the Kansas register.

8 Sec. 15. K.S.A. 2021 Supp. 4-514 and 4-526 are hereby repealed.

9 Sec. 16. This act shall take effect and be in force from and after its
10 publication in the Kansas register and the date of publication in the Kansas
11 register of the notice prescribed in section 14.
