7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. (a) The administrator or operator of each adult residential  
9 care facility shall ensure that a resident is not involuntarily transferred or  
10 discharged from the adult residential care facility unless one or more of the  
11 following conditions are met:

12 (1) The transfer or discharge is necessary for the resident's welfare  
13 and the resident's needs cannot be met by the current adult residential care  
14 facility;

15 (2) the health or safety of other individuals in the adult residential  
16 care facility is endangered;

17 (3) the resident has failed, after reasonable and appropriate notice, to  
18 pay the rates and charges imposed by the adult residential care facility; or

19 (4) the adult residential care facility ceases to operate.

20 (b) Before a resident may be transferred or discharged involuntarily,  
21 the administrator or operator, or designee, shall:

22 (1) Notify the resident, and, if known, a representative or designated  
23 family member, of the transfer or discharge and the reason for the transfer  
24 or discharge;

25 (2) if the reason for transfer or discharge is specified in subsection (a)  
26 (1) through (a)(3), record and substantiate in the resident's clinical record  
27 as follows:

28 (A) The resident's physician shall document the rationale for transfer  
29 or discharge in the resident's clinical record if the transfer or discharge is  
30 necessary for the resident's welfare and the resident's needs cannot be met  
31 by the adult residential care facility;

32 (B) the resident's physician shall document the rationale for transfer  
33 or discharge in the resident's clinical record if the transfer or discharge is  
34 appropriate because the resident's health has improved sufficiently so that  
35 the resident no longer needs the services provided by the adult residential  
36 care facility; or

1 (C) a physician shall document the rationale for transfer or discharge  
2 in the resident's clinical record if the transfer or discharge is necessary  
3 because the health or safety of other individuals in the adult residential  
4 care facility is endangered; and

5 (3) provide a written transfer or discharge notice that shall include the  
6 following:

7 (A) The reason for the transfer or discharge;

8 (B) the effective date of the transfer or discharge;

9 ~~(C) the contact information for the state long-term care ombudsman;~~

10 ~~(D) the resident's right to appeal an involuntary transfer or discharge~~  
11 ~~established under this section and information as designated by the~~  
12 ~~secretary to assist the resident in exercising such right;~~

13 (E) for a resident with an intellectual or developmental disability,  
14 dementia or another cognitive-limiting condition, the contact information  
15 for the agency responsible for the protection and advocacy of individuals  
16 with such conditions; and

17 (F) for a resident with a mental disorder or related disability, the  
18 contact information for the agency responsible for protection and advocacy  
19 of individuals with a mental disorder or related disability.

20 (c) The administrator or operator, or designee, shall provide the  
21 notice of transfer or discharge required by subsection (b) to the resident, or  
22 the resident's representative, at least 30 days in advance of the resident's  
23 transfer or discharge, unless:

24 (1) The safety of other individuals in the adult residential care facility  
25 would be endangered; or

26 (2) the resident's urgent medical needs require an immediate transfer  
27 to another healthcare facility.

28 (d) The administrator or operator, or designee, shall provide sufficient  
29 preparation and orientation to each resident before a resident's discharge,  
30 including development of a discharge plan, with involvement of the  
31 resident, the resident's representative and designated family and subject to  
32 approval of ~~the resident's physician, if practicable.~~

33 (e) ~~(1) If a resident of an adult residential care facility receives notice~~  
34 ~~of a pending involuntary transfer or discharge in violation of this section,~~  
35 ~~such resident, or such resident's representative, may appeal the adult~~  
36 ~~residential care facility's determination to involuntarily transfer or~~  
37 ~~discharge the resident to the secretary for aging and disability services by~~  
38 ~~filing a notice of appeal in the office of administrative hearings within 15~~  
39 ~~days after the date of such notice. A presiding officer from the office of~~  
40 ~~administrative hearings shall hold a hearing, in accordance with the~~  
41 ~~provisions of the Kansas administrative procedure act, within 30 days after~~  
42 ~~the receipt of the notice of appeal.~~

43 ~~(2) If a resident files an appeal pursuant to this section, the resident~~

an affirmative statement listing what services are necessary for the resident that the existing negotiated services agreement with the facility does not include

The administrator or operator, or designee, shall provide the secretary for aging and disability services and the state long-term care ombudsman a copy of the notice. The secretary and the state long-term care ombudsman shall maintain the copy of the notice for three years.

the secretary for aging and disability services shall investigate such violation. The secretary, providing notice and an opportunity for a hearing in accordance with the Kansas administrative procedure act, may assess a civil penalty against any facility that violates this section in an amount not to exceed \$5,000.

(g) The state long-term care ombudsman shall publish an annual report regarding notices issued and violations of this section.

8 available to all adult residential care facilities a 30-day involuntary transfer  
9 or discharge notice form that shall include, but not be limited to, the  
10 information in subsection (c).

11 (b) The administrator or operator of an adult residential care facility,  
12 or designee, shall not be required to use the 30-day involuntary transfer or  
13 discharge notice form prescribed by the secretary, but any form used by  
14 the facility shall include, but not be limited to, the information in  
15 subsection (c).

16 (c) A 30-day involuntary transfer or discharge notice shall be written  
17 and include, but not be limited to:

the same contents as required for notice in Section 1, and amendments thereto.

11 ~~Sec. 4. (a) The administrator or operator of an adult residential care~~  
12 ~~facility, or designee, shall deliver the notice to the resident in person and~~  
13 ~~place a copy in the resident's record. On the same day, the administrator or~~  
14 ~~operator, or designee, shall send the notice to:~~

15 ~~(1) The resident's representative in person, by return receipt delivery,~~  
16 ~~or by email, read receipt requested; and~~

17 ~~(2) the state long-term care ombudsman in person or by email.~~

18 ~~(b) The administrator or operator, or designee, shall document~~  
19 ~~acknowledgment of receipt of the 30-day involuntary transfer or discharge~~  
20 ~~notice by all required recipients by obtaining and maintaining:~~

21 ~~(1) The recipient's signature on the 30-day involuntary transfer or~~  
22 ~~discharge notice form;~~

23 ~~(2) the return receipt affirming delivery of the notice; or~~

24 ~~(3) an electronic read receipt from the recipient's email.~~

25 ~~(c) If the recipient refuses receipt of the notice, the administrator or~~  
26 ~~operator, or designee, shall give the document to the recipient through a~~  
27 ~~different method of delivery. The administrator or operator, or designee,~~  
28 ~~shall document the refusal. After attempting delivery by two different~~  
29 ~~methods, if the recipient refuses delivery through both methods, the notice~~  
30 ~~is deemed to be received by the recipient.~~

31 ~~Sec. 5. (a) Except when a facility had its license revoked or not~~  
32 ~~renewed by the secretary for aging and disability services or voluntarily~~  
33 ~~surrendered a license, a resident who receives a 30-day involuntary~~  
34 ~~transfer or discharge notice shall be entitled to an administrative hearing if~~  
35 ~~the resident or the resident's representative requests an administrative~~  
36 ~~hearing in a timely manner.~~

37 ~~(b) A resident who receives a 30-day involuntary transfer or discharge~~  
38 ~~notice, the resident's representative or the state long-term care~~  
39 ~~ombudsman, if requested and on behalf of the resident or the resident's~~  
40 ~~representative, may appeal such transfer or discharge by filing a notice of~~  
41 ~~appeal with the office of administrative hearings within 15 calendar days~~  
42 ~~after the issue date printed on the notice. The secretary may extend the~~  
43 ~~time allowed for requesting an administrative hearing if the secretary~~

1 ~~determines that good cause exists for the failure to make a timely request.~~

2 ~~(c) If the resident is incapacitated and does not have a representative,~~  
3 ~~the state long-term care ombudsman may file a notice of appeal on behalf~~  
4 ~~of the resident.~~

5 ~~(d) If the resident or the resident's representative files the notice of~~  
6 ~~appeal form to the office of administrative hearings, on the same day the~~  
7 ~~resident files the notice of appeal to the office of administrative hearings,~~  
8 ~~the resident shall give a copy of the completed notice of appeal to the~~  
9 ~~administrator or operator, or designee, and the state long-term care~~  
10 ~~ombudsman.~~

11 ~~(e) If the state long-term care ombudsman completes or files the~~  
12 ~~notice of appeal form at the request of the resident or the resident's~~

15 ~~term care ombudsman shall give a copy of the completed notice of appeal~~

22 ~~within 10 business days after the completion of the administrative hearing.~~

24 ~~discharge notice shall be allowed to continue to reside in the facility until~~  
25 ~~the hearing process is completed. The resident shall be responsible to pay~~

28 ~~Sec. 6. (a) After a notice of appeal has been filed but before the~~  
29 ~~administrative hearing, the following people may request the secretary to~~

33 ~~(3) the administrator or operator of an adult residential care facility,~~

 16 ~~the resident, or the resident's representative, prior to or within 48 hours~~  
 17 ~~following the transfer or discharge. A copy of the notice shall be provided~~  
 18 ~~to the secretary and the state long-term care ombudsman.~~  
 19 ~~(b) If the resident has already been transferred or discharged on an~~  
 20 ~~emergency basis, the administrator or operator, or designee, shall hold a~~  
 21 ~~space available for the resident pending receipt of an administrative~~
