1 AN ACT concerning roads and highways; designating a portion of United
2 States highway 69 as the Ken W Brock memorial highway;
3 *designating a portion of United States highway 81 as the Merle*
4 *Miller memorial highway*; designating a portion of United States
5 highway 281 as the first responders memorial highway;
6 *redesignating a current portion of the Frank Carlson memorial*
7 *highway for United States highway 81*; redesignating a current
8 portion of the American Legion memorial highway for United
9 States highway 281; *amending K.S.A. 68-1011 and 68-1036 and*
10 *repealing the existing ~~section~~ sections.*

12 *Be it enacted by the Legislature of the State of Kansas:*

13 *New Section 1. The portion of United States highway 69 from the*
14 *junction of United States highway 69 and grand road in Bourbon county,*
15 *then south on United States highway 69 to the junction of United States*
16 *highway 69 and east 650th avenue in Crawford county is hereby designated*
17 *as the Ken W Brock memorial highway. Upon compliance with K.S.A. 68-*
18 *10,114, and amendments thereto, the secretary of transportation shall place*
19 *suitable signs to indicate that the highway is the Ken W Brock memorial*
20 *highway.*

21 *New Sec. 2. The portion of United States highway 81 where it*
22 *enters the state on the Kansas-Nebraska line, then south on United*
23 *States highway 81 to the southern border of Republic county is hereby*
24 *designated as the Merle Miller memorial highway. Upon compliance*
25 *with K.S.A. 68-10,114, and amendments thereto, the secretary of*
26 *transportation shall place suitable signs to indicate that the highway is*
27 *the Merle Miller memorial highway.*

28 *New Sec. 3. The portion of United States highway 281 from the*
29 *southern city limits of Russell, then north to its junction with K-18*
30 *highway in Russell county is hereby designated as the first responders*
31 *memorial highway. Upon compliance with K.S.A. 68-10,114, and*
32 *amendments thereto, the secretary of transportation shall place*
33 *suitable signs along the highway right-of-way at proper intervals to*
34 *indicate that the highway is the first responders memorial highway.*

1 Sec. 4. K.S.A. 68-1011 is hereby amended to read as follows: 68-
2 1011. The portion of United States highway ~~no.~~ 281 traversing this
3 state where it crosses the Nebraska-Kansas boundary line on the north
4 to the junction of United States highway 281 and K-18 highway, then from
5 the southern city limits of Russell to the point where it leaves the state on
6 the south at the Kansas-Oklahoma boundary line, be and it is hereby
7 designated as "the American Legion memorial highway" in the state
8 of Kansas.

9 ~~Sec. 3.~~ 5. K.S.A. 68-1036 is hereby amended to read as follows: 68-
10 1036. The portion of United States highway 81 ~~where it enters the state~~
11 ~~on the Kansas-Nebraska line on the north thence south from the northern~~
12 ~~border of Cloud county, then south on United States highway 81 to the~~
13 ~~junction of interstate highway I-70 is hereby designated the Frank~~
14 ~~Carlson memorial highway. The secretary of transportation shall place~~
15 ~~suitable signs along the highway right-of-way at proper intervals to~~
16 ~~indicate the highway is the Frank Carlson memorial highway. The~~
17 ~~secretary of transportation may accept and administer gifts and~~
18 ~~donations to aid in obtaining suitable highway signs.~~

19 ~~Sec. 4.~~ 6. K.S.A. 68-1011 and 68-1036 ~~is~~ are hereby repealed.

20 ~~Sec. 2.~~ ~~5.~~ 7. This act shall take effect and be in force from and after
21 its publication in the statute book.
